**TRIAL MEMBERSHIP CONTRACT**

In consideration of membership at CRYCC, Member does hereby agree to the following terms and conditions and to pay all dues, and other charges subject to the following terms and conditions.

1. All dues are billed by the month prior to the start of the month. Appropriate prorating is done upon acceptance of membership. There is no prorating upon resignation or termination of membership.
2. Should membership privileges be suspended pursuant to the By-Laws of CRYCC, the member's membership will be terminated at the conclusion of the next month. Prior to being reinstated, the member shall pay all past due charges, including all dues that would have come due through the reinstatement, plus the reinstatement fee of in effect at the time of rejoin.
3. Members shall pay a finance charge of 1.5% per month for each month or portion thereof for which an invoice remains more than 30 days past due.
4. Members shall be charged attorney's fees for any suit filed to collect any delinquent balance due. Attorney's fees shall be \$150.00 upon referral to club counsel, and additional \$250.00 upon filing a suit, and an additional 25% of the balance due upon entering of a judgment.
5.
