**MEMBERSHIP CONTRACT**

This contract made this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between Chester River Yacht and Country Club of Maryland, Inc. (hereafter "CRYCC") and \_\_\_\_\_ (hereafter "Member").

In consideration of membership at CRYCC, Member does hereby agree to the following terms and conditions and to pay all dues, initiation fees, minimums, and other charges subject to the following terms and conditions.

1. All dues are billed by the quarter prior to the start of the quarter. Appropriate prorating is done upon acceptance of membership. There is no prorating upon resignation or termination of membership.
2. Should membership privileges be suspended pursuant to the By-Laws of CRYCC, the member's membership will be terminated at the conclusion of the next quarter. Prior to being reinstated, the member shall pay all past due charges, including all dues that would have come due through the reinstatement, plus the reinstatement fee of in effect at the time of rejoin.
3. Members shall pay a finance charge of 1.5% per month for each month or portion thereof for which an invoice remains more than 30 days past due.
4. All unpaid initiation fees, whether financed over time or not, are due in full upon the termination of the membership.
5. Upon termination, stock must be returned to CRYCC pursuant to the By-Laws of CRYCC. The par value of the stock will be deducted from any outstanding balance the Member may have with any remaining credit, if any, being returned to the Member within 30 days of the effective date of the resignation.
6. Members shall be charged attorney's fees for any suit filed to collect any delinquent balance due. Attorney's fees shall be \$150.00 upon referral to club counsel, and additional \$250.00 upon filing a suit, and an additional 25% of the balance due upon entering of a judgment.
