

FULL MEMBERSHIPS

Includes full and unlimited Club privileges: Golf, Clubhouse, Pool, Bocce, Waterfront and Dining. The category types are:

SENIOR: *(Please specify which Senior category type on application.)*

Single Senior: For unmarried or widowed individuals over the age of 80.

Double Senior: Both individuals on the membership are over the age of 80.

Annual Dues: \$1,725 (\$431.25 billed quarterly)

Mixed Senior: One of two individuals on the membership are over the age of 80.

Annual Dues: \$2,627 (\$656.75 billed quarterly)

FULL FAMILY: For persons between the ages of 36 and 80. Includes your spouse and unmarried children under the age of 18 who are not self supporting. Any child up to the age of 27 may retain their privileges while in school or in active military service.

Annual Dues: \$3,502 (\$875.50 billed quarterly)

FULL SINGLE: for unmarried persons between the ages of 36 and 80.

Annual Dues: \$2,627 (\$656.75 billed quarterly)

JUNIOR: Open to persons under the age of 35, their spouse*, and unmarried children under the age of 18 years. *Spouse must also be under 35 years of age.

Annual Dues: \$1,725 (\$431.25 billed quarterly)

LEGACY: Open to persons under the age of 35, whose parent or grandparent have been a Club member for 20 years. Includes spouse and unmarried children under the age of 18.

Annual Dues: \$1,725 (\$431.25 billed quarterly)

SOCIAL MEMBERSHIP: For persons of any age, married or single.

Includes your spouse and unmarried children under the age of 18 who are not self supporting. Any child up to the age of 27 may retain their privileges while in school or in active military service. Includes Clubhouse, Pool, Bocce, and Waterfront privileges. A Social membership includes twelve (12) nine hole rounds or six (6) 18-Hole rounds per immediate family member on the membership with the payment of a reduced greens fee. A Social member may have access to the driving range with the payment of an annual golf fee. There is no discount for single memberships.

Annual Dues: \$1,308 (\$327 billed quarterly)

HOUSE MEMBERSHIP: For persons of any age, married or single.

Includes your spouse and unmarried children under the age of 18 who are not self supporting. Any child up to the age of 27 may retain their privileges while in school or in active military service. Includes Clubhouse privileges only. There is no discount for single memberships.

Annual Dues: \$832 (\$208.00 billed quarterly)

All membership categories are subject to a quarterly food minimum:

Single Members - \$75.00 per quarter, Multiple (Family) Members - \$150 per quarter

Monthly Assessments - \$40.
